DECISIONS

10YFP demonstrating progress and impact indicators defined

The 10YFP Monitoring and Evaluation (M&E) task force, chaired by Finland /SBC programme, has agreed on 20 indicators for the 10YFP. Such a framework aims to support the 10YFP actors and other stakeholders working on SCP: (i) assess and improve performance to inform the planning of activities and allocation of funds; and (ii) report and demonstrate progress to show accountability towards all actors and donors, communicate results to the wider public, and mobilise political and financial support. The framework is available here.

The first data collection and reporting effort will start in January 2017.

The <u>Beijing Declaration</u> on Sustainable Tourism as a driver of Development and Peace, adopted in May 2016 at the First World Conference on Tourism Development organized by the Government of the People's Republic of China and the World Tourism Organization (UNWTO), recalled the role of the 10YFP Sustainable Tourism Programme in encouraging the shift towards green growth and sustainable development. Further, the declaration called upon governments to integrate and prioritize sustainable consumption and production in national planning and policymaking, including tourism, to accelerate the shift towards more sustainable consumption and production patterns.

Costa Rica has established a National SPP Committee and has enacted the decrees supporting the implementation of the national SPP policy. SPP guidelines and training materials have been drafted. The national policy foresees the implementation of an ecolabelling scheme, the development of measures to facilitate the participation of small and medium enterprises on SPP, and the promotion of research and trainings.
